Michael Brian Pross, 52, of Mooresville, passed away on Thursday, August 16, 2018.

He was born on February 11, 1966 in Schenectady, NY to Norman and Gail Michon Pross. Mr. Pross was an attorney with Wallace & Graham Law Firm in Salisbury from nearly 20 years. He played lacrosse in college and earned his black belt in Tae Kwan Do with his daughter. He enjoyed traveling, fishing, horse racing, watching Carolina Panther football, and mountain biking with his German Shepherd, Koda. He was the team mascot for this daughter's cheerleading squad and never missed a cheer competition. Michael enjoyed going to Belize on Mission trips, where he built a well to bring water to a town for the first time. He sat on the Board of Trustees for the Turneffe Atoll Trust in Belize, which helped to protect fisheries and preserve wildlife.

In addition to his parents, he is survived by his wife, Kimberly Bordner Pross; daughter, Sara Pross; brother, Jeff Pross and wife, Amy; and father and mother-in-law, Don and Linda Bordner.
